ABOUT THE SEMINAR

The 1st International Conference on *Child Rights Abuse and Juvenile Justice: Contemporary Trends*, organized by the Centre for Criminal Law and Criminology, ICFAI Law School and convened by Dr. Hans Kumar Sharma, was successfully held at the ICFAI University, Jaipur, on September 28th, 2024. The conference addressed critical issues concerning child rights, juvenile justice and emerging trends in these fields. It brought together academics, legal professionals, social workers, researchers, and students to discuss contemporary challenges and solutions for safeguarding child rights. A total of 84 research paper abstracts were received from across India, out of which 30 were selected through a rigorous peer-review process, and 26 full papers were submitted, involving 26 authors and 12 co-authors. Additionally, four candidates attended the conference as participants to observe and gain knowledge

The keynote speaker via online was Dr. Camille Gibson, Professor and Interim Dean at Prairie View A&M University, Texas. Ten research papers were presented during the session.

TECHNICAL SESSION - II

Both sessions highlighted pressing issues such as child sexual abuse, online exploitation, juvenile recidivism, and the long-term psychological effects of childhood trauma. Legal frameworks were critically analyzed for their effectiveness, with discussions emphasizing the need for stronger enforcement of child protection laws and improved rehabilitation programs. The conference concluded by reaffirming the importance of ongoing research, dialogue, and advocacy in safeguarding children's rights. The insights shared will play a crucial role in shaping future policies and interventions in child rights and juvenile justice.

Soon after the Prize Distribution Ceremony, Vote of Thanks was proposed by the Convener of the Conference, Dr. Hans Kumar Sharma.
