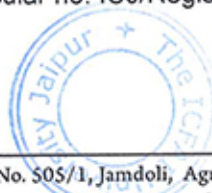


University Student Grievance Redressal Committee (USGRC)

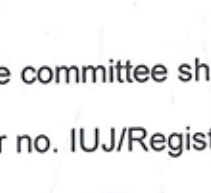
