Terms and conditions of the Research Incentive Scheme:

- > The Scheme is applicable only to the faculty members of ICFAI University, Jaipur.
- > A faculty member who is the only author of the research paper will be given 100% of the incentive amount.
- In case of co-authors in the research paper
 - When a faculty member is the 1st author he/she will be given 60% of the incentive amount.
 - When a faculty member is the 2nd or subsequent co-author, (n-1)th part of 40% of the incentive amount will be given (where n' represents the total number of authors in the paper).
 - The scheme will be operated prospectively.
 - The incentive will be payable on half yearly review (September & March).
 - This scheme to be eligible, the published paper should properly acknowledge the ICFAI University, Jaipur.
