

# MEMORANDUM OF UNDERSTANDING

**Between**

**The ICFAI University, Jaipur**

**And**

**Prayaas Corps, A Non-Profit Organisation**

This Memorandum of Understanding (hereinafter referred to as the "MoU") is entered into on this 22 day of July, 2025, by and between:

**The ICFAI University Jaipur (hereinafter referred to as IUJ)** has been established under The ICFAI University, Jaipur Act, 2011 (Act No. 26 of 2011) passed by Legislative Assembly of Rajasthan. The University has been notified under Notification No. F. 2(26) Vidhi/2/2011 dated September 22, 2011. The University is sponsored by The ICFAI Society - a not-for profit educational society established in 1984. Presently, IUJ runs professional education programmes in Engineering, Pharmacy, Computer Application, Management, Law and Applied and Health Sciences. The IUJ Campus Address is at The ICFAI University, Jaipur Near Cambay Golf Resort, Agra Road, Jamdoli, Jaipur - 302031, Rajasthan

**AND**

Prayaas Corps, a non-profit organisation registered under Section 8 of the Companies Act, 2013, having its registered office at 14, Parwati Enclave, Manyawaas, Mansarovar, Jaipur-302020, Rajasthan, India (hereinafter referred to as "Prayaas Corps", which expression shall unless repugnant to the context or meaning thereof, include its successors and permitted assigns) (Collectively referred to as the "Parties" and individually as a "Party").

## **1. Purpose**

This MoU aims to establish a framework for cooperation between ICFAI University Jaipur and Prayaas Corps for:

- Academic and community-oriented collaboration
- Internships and volunteer opportunities for university students with Prayaas Corps
- Joint seminars, workshops, and outreach programs
- Research, development, and knowledge exchange on social issues
- Curriculum input and skill-based training aligned with societal needs



- Capacity building and leadership development programs

## 2. Areas of Collaboration

The areas of mutual cooperation may include but are not limited to:

- Facilitating student internships and social immersion programs at Prayaas Corps
  - Organizing guest lectures, field visits, awareness drives, and training sessions
  - Promoting collaborative research on social challenges, education policy, etc.
  - Involving students and faculty in rural development, skill training and literacy campaigns
  - Development of joint proposals for funding and grants from national/international agencies

## 3. Nature of the Collaboration

- The collaboration will be **non-financial and voluntary** in nature.
  - Both Parties will share human resources, expertise, knowledge, and platforms as per mutual availability and consent.
  - Either party may propose specific programs, which will be jointly reviewed and executed as mutually agreed.

## 4. Roles and Responsibilities

ICFAI University Jaipur shall:

- Nominate a nodal coordinator for implementing the activities outlined in this MoU
- Facilitate student and faculty participation in programs conducted by Prayaas Corps
- Recognize internships with Prayaas Corps as part of its academic curriculum (if applicable)

Prayaas Corps shall:

- Provide meaningful internship and community exposure opportunities to students
  - Allow access to its project sites for research and outreach work
  - Coordinate with university faculty for knowledge-sharing sessions and workshops

## 5. Duration and Termination

- This MoU shall remain valid for a period of **three (3) years** from the date of signing.
- The MoU may be extended upon mutual written consent.

- Either party may terminate the MoU by providing **30 days' written notice** to the other party without any legal or financial obligations.
- In the event of termination, ongoing programs shall be completed or mutually resolved.

## 6. Confidentiality

Both parties agree to maintain the confidentiality of information shared under this MoU and not to disclose it to any third party without prior written consent, except as required by law.

---

## 7. General Provisions

- This MoU does not create any legal or financial liability between the Parties.
- All activities undertaken will be governed by applicable institutional, academic, and legal frameworks.
- The names and logos of either party shall not be used for any commercial purpose without prior written consent.

## 8. Dispute Resolution


In case of any disputes arising under this MoU, the Parties agree to resolve such disputes amicably through mutual consultation.

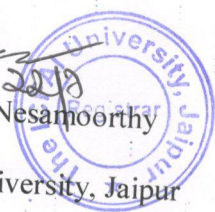


