



MEMORANDUM OF UNDERSTANDING
BETWEEN
S S ENVIROCARE (A Unit of S S Envirocare Private Limited)
&
THE ICFAI UNIVERSITY, JAIPUR

This Memorandum of Understanding ("MOU") is entered at Jaipur (Rajasthan) on 05th August'25
(Effective Date)

BETWEEN

S S ENVIROCARE (A UNIT OF S S ENVIROCARE PRIVATE LIMITED) having its Registered Office at 84, Marudhar Nagar, Ajmer Road, Jaipur, Rajasthan 302021 (herein after referred as "S S Envirocare") represented by Mr. Mishank Sharma (Director, SS Envirocare).

AND

THE ICFAI UNIVERSITY, JAIPUR, Jaipur having its Institute Office at KHASRA NO.505/1, NEAR CAMBAY GOLF, JAMDOLI, AGRA ROAD, JAIPUR RAJASTHAN - 302031 (herein referred as "The ICFAI University, Jaipur") represented by the Registrar, The ICFAI University, Jaipur.

SS Envirocare and The ICFAI University, Jaipur shall hereinafter be individually referred to as a "Party" and collectively be referred to as the "Parties".

WHEREAS:

1. S S Envirocare is an E-Waste Recycling Facility authorized by Rajasthan Pollution Control Board for safe handling of electrical and electronic waste as per E-Waste (Management) Rules 2022.
2. S S Envirocare is operating a facility for the collection, transportation, recycling and disposal of E-Waste in Jaipur, Rajasthan.
3. The ICFAI University, Jaipur in compliance with E-Waste (Management) Rules 2022, desires to avail the services of S S Envirocare for disposal of their segregated E-Waste from the site.
4. The ICFAI University, Jaipur has approached S S Envirocare and desires to appoint S S Envirocare for the purpose of collection and disposal of its segregated E-Waste and the same has been accepted by S S Envirocare in accordance with the terms of this MOU.

NOW THIS MEMORENDUM OF UNDERSTANDING witnesses as follows;

I. DEFINITIONS AND INTERPRETATION

Electronic Waste – The term E-Waste will refer to the electronic and electrical items mentioned in the Schedule I of E-Waste (Management) Rules 2022, for the purpose of this MOU.

II. SCOPE OF THE MOU

1. S S Envirocare shall collect, transport, and dispose the E-Waste collected from the premises of The ICFAI University, Jaipur. It shall be the responsibility of S S Envirocare to destroy the data from the hard disks before disposing them off in accordance with the terms of the MOU.
2. The ICFAI University, Jaipur shall appoint a dedicated representative who shall be responsible for operational, delivery and day to day management of the Service and act as the principal point of contact under this MOU. Any notice seeking clarification served on such representative shall be deemed to have been served on the Party concerned. The representative of Client shall sign Form 6 under the compliance of the E-Waste Management & Handling Rules, 2016, and such other required documents for acknowledging the E-Waste being handed over to S S Envirocare.
3. The ICFAI University, Jaipur shall segregate the E-Waste at one designated place within the premises from where the representatives of S S Envirocare shall collect the E-Waste.
4. Upon intimation from The ICFAI University, Jaipur, S S Envirocare shall within 15 days there from, arrange for collection of E-Waste as per the applicable provisions. The ICFAI University, Jaipur shall issue delivery challan before collection of the E-Waste from the designated place by S S Envirocare.
5. The E-Waste collected shall be weighed by the Parties at the nearest weighment center available as identified by the Parties. The weighment of the E-Waste shall be done in the presence of the representatives of both the Parties and both the Parties shall acknowledge such weighment slip generated. In case of any discrepancy in the weighment as per delivery challan and the weighment slip, the details as per weighment slip shall be considered for payment by S S Envirocare.
6. The ICFAI University, Jaipur liability shall cease once the E-Waste has been collected by S S Envirocare from its premises except for any non-disclosure of any material information known to The ICFAI University, Jaipur with regard to E-Waste from S S Envirocare during the handover of such E-Waste. It is specifically agreed and understood that compliances of applicable law during the transportation and disposal of E-Waste shall be exclusive responsibility of S S Envirocare.
7. S S Envirocare shall, issue a Recycling Certificate as prescribed under applicable laws within Thirty (30) days from receipt of such request.

III. PAYMENTS

1. **Payment Terms:** As per agreed terms between S S Envirocare and The ICFAI University, Jaipur, valuation will be based on the present fair market rates.
2. **Time of Payment:** The payment shall be made by S S Envirocare immediately upon delivery of the E-Waste, in the form of electronic transfer/cheque.
3. **Other Terms and Conditions:** Any additional terms and conditions related to the commercial aspects of the engagement shall be detailed in a separate Commercial Agreement or Invoice.

IV. TERM AND TERMINATION

1. The MOU shall be in force for a period of 3 year from the date of signing of this MOU. Upon completion of this term, the MOU may be renewed at the option of both the parties in writing on mutually agreed terms and conditions.
2. The MOU may be terminated by either party without assigning any reason, by giving fifteen (15) days prior written notice to the other party.

V. COMPLIANCE WITHIN LAWS

1. S S Envirocare represents and warrants to The ICFAI University, Jaipur that it has all necessary statutory permissions, consents, approvals and licenses to carry out business of collection, transportation, storage, management and disposal of E-Waste and it shall maintain all such permissions, consents, approvals and licenses during the term of this MOU.
2. S S Envirocare further agrees that:
 - i. It shall exercise all safety precaution and best management practices, required by law, in providing service under this agreement.
 - ii. It shall notify The ICFAI University, Jaipur immediately if any permit, licenses, certificate, consent approval or identification number required for the performance of its service under this MOU has been revoked, modified, expired, suspended or not been renewed.
 - iii. S S Envirocare shall comply with all applicable laws, rules and regulations and shall indemnify and hold Client harmless in this regard.

VI. DISPUTE RESOLUTION

1. This MOU shall be governed and construed in accordance with the laws of India.
2. Any dispute or breach arising out of or in relation to this MOU shall be referred to arbitration to be conducted by a sole arbitrator mutually appointed by the parties herein, in accordance with the Arbitration and Conciliation Act, 1996. The venue of arbitration shall be Jaipur and the proceedings shall be conducted in English. The decision of the arbitration shall be final and binding on both the Parties. No Party shall make public the award of the arbitration without the prior written consent of the other Party. The Party in default shall bear the cost of arbitration.

3. Subject to the arbitration provisions herein, courts of competent jurisdiction in Jaipur shall have the exclusive jurisdiction on the matters arising out of or in connection with this MOU. No Party shall be restrained from approaching the court for seeking interim relief under this MOU.
