## Incubation Centre / Start-ups / Entrepreneurship Cell at ICFAI University Jaipur

The ICFAI University, Jaipur, in alignment with the directives of the Ministry of Education's Innovation Cell (MIC), Government of India, has established an Institution's Innovation Council (IIC) on campus to systematically promote a culture of innovation, entrepreneurship, and startup incubation among students and faculty members.

The IIC was formally constituted during the academic year 2020–21, with registration code IC202115545 and Certificate No. 5089, dated January 30, 2021, under AISHE Code U-0871.

The IIC at The ICFAI University, Jaipur, is committed to fostering a culture of innovation and entrepreneurship. Its primary objectives are to:

- Promote innovation and entrepreneurial spirit within the university community
- Serve as the nodal body for coordinating innovation-related activities and programs
- Collaborate with government agencies, industry partners, and other institutions to support innovation and entrepreneurship initiatives

Since its inception, the IIC has undertaken several impactful initiatives to advance innovation and entrepreneurship on campus. These include the formal inauguration of the IIC Chamber and logo, expert sessions such as one delivered by TEDx speaker Mr. Mridul Kabra on digital entrepreneurship, and a collaborative seminar on industrial digitization in partnership with the National Productivity Council and Rajasthan State Productivity Council. The Council has also organized a sensitization session on gender equity for the employees of Oil India Limited.

In addition, the IIC has conducted various awareness and celebration activities such as International Women's Day, World Creativity and Innovation Day, World Intellectual Property Rights (IPR) Day, and a workshop on IPR. Regular quarterly meetings are held to review progress and strategize future initiatives. The Council has also contributed to the MIC-driven initiative of building the YUKTI Innovation Repositories.

Furthermore, the IIC actively encourages students and faculty to participate in both internal and external innovation-related events. These include delegations to state and national-level programs, such as participation in Anveshan organized by the Association of Indian Universities (AIU) in January 2025, and involvement in business plan competitions hosted by institutions across and beyond the state of Rajasthan. Through these ongoing efforts, the IIC continues to strengthen the university's innovation and entrepreneurial ecosystem.
