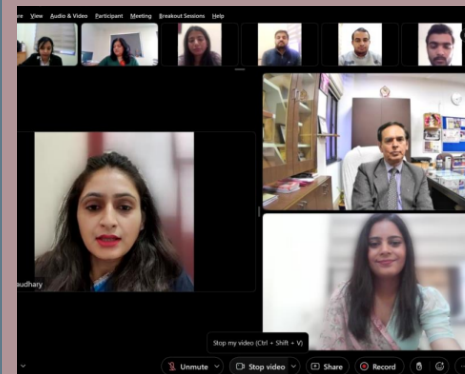


ACTIVITIES BY COMMITTEES
