The topic of the Essay Writing competition was "Basic structure doctrine: Its constitutional journey in the last 50 years." The competition was conducted in Computer Lab from 3:00 PM to 4:00 PM.

It must be noted that the entire functioning of the event was held in the electronic mode with the objective of conserving the environment. Students securing winner and runner up titles shall be felicitated with the certificate and trophies in a ceremony subsequent to the declaration of results.
